The courtyard is also adjacent to one of the main music and dance stages in the Festival. Tents will be set up for the artists to provide a welcoming place, rain or shine.

- Saturday, July 27, noon 8:30 pm (overnight storage for artwork will be provided)

Selection:

In order to ensure the quality, variety and aesthetics of this exhibition, assistance will be provided by a six-member jury of qualified arts professionals and the US Park Service. Samples of your work may be submitted for jurying in one of two ways:

- **Website.** On the application form below, clearly print your website's URL in the appropriate box. We will visit your website to view your work.
- **CD.** On a CD, provide up to 4 images of your work. Images must be in JPEG or TIFF format. Clearly print your name, phone number and e-mail address **directly on the front of your CD in indelible ink**. It is suggested that you put your CD in a protective envelope. **No DVD disks, please.** After you create your CD, test it to make sure it opens and is readable <u>on a PC</u>.

***Important: Sorry, images cannot be accepted by e-mail.

Payment Details:

- Non-refundable application/jury fee of \$25.00 due **June 1**
- Sharing spaces is permitted up to a total of three artists in one tent, but each participating artist must submit an application, \$25.00 application fee, CD (or website URL) and must be juried.
- If you are selected, your tent fee is due **June 29**
 - One artist in a 10 x 10 space: \$300
 - O Two artists in a 10 x 10 space: \$175 each, \$350 total
 - o Three artists in a 10 x 10 space: \$120 each, \$360 total

- * Event Dates: Saturday, July 27, noon 8:30 and Sunday, July 28, noon 6:00 pm
- * **Space:** Space will be assigned in the order applications are received and to ensure that different media are distributed in such a way as to avoid duplication. It is understood and agreed that Art in the Courtyard 2013 is providing 10x10 tented space, 1 table and 2 chairs only; any additional structures needed for the exhibitor's area must be provided by exhibitor and removed by 6:00 p.m., July 28, 2013 leaving the immediate space clean.
- * **Security:** There is a locked facility in which to store your work over night, Saturday, July 27, 2013. You should not leave your artwork or belongings in your tent overnight.
- * Type of Items to be Sold: Because this event is being held on National Park property, alcoholic beverages are prohibited and items sold or distributed in your exhibitor's area are to be appropriate for a family oriented event. Please read attached restrictions before signing this agreement.
- * *Indemnity Agreement:* In consideration of the acceptance of this application, we agree to comply with the rules and hold harmless The Brush Art Gallery, The Cultural Organization of Lowell, The National Park or any partnering sponsors or organizations from any loss or damage to persons or property arising out of our participation in Art in the Courtyard to be held in the National Park Market Mills Courtyard on July 27 and July 28, 2013.

Art in the Courtyard Important Information and Restrictions

Registration Information:

• A 10' x 10' tented space with one table and two chairs for Saturday and Sunday

General Information:

- Held in conjunction with the Lowell Folk Festival. The Folk Festival has over 100,000 visitors annually.
- Held in the brick-lined, shaded courtyard between the National Park Visitor Center, and the Brush Art Gallery & Artists' Studios
- Positioned on a heavily traveled route between a major sound/dance stage and other festival activities
- Volunteers to mind your table while you take a break
- Free to public
- Public restrooms on both sides of courtyard
- Many restaurants, cafes and Festival food tents within easy walking distance
- Locked, overnight storage will be provided on Friday and Saturday
- Correspondence and notification will be done entirely by e-mail, so please make sure your e-mail address is printed *very clearly* on your application. **Make sure to check your e-mail frequently**.

Restrictions:

- exhibitor must use Lowell Folk Festival tents, which are in included in the booth fee, along with 1 table and 2 chairs. Any additional display structures must be provided by the exhibitor. No additional tents/coverings are permitted
- no commercial items for resale, kits, imported or consigned goods, no recordings or CDs
- no publications permitted for sale except for items such as books entirely illustrated by the artist or entirely written by the artist (i.e. poetry, prose, short stories, etc.)
- artwork/crafts must be produced by the exhibitor
- duplicate arts and fine crafts will be limited as far as possible
- exhibitors must remain for entire show; no late set-ups or early breakdowns.
- please plan for sufficient inventory
- no alcoholic beverages
- artwork must be appropriate for family viewing
- exhibitor is responsible for handling own sales
- exhibitor is responsible for collecting and forwarding Massachusetts sales tax to Mass. Dept. of Revenue
